The system was created to provide easy access to a wide variety of information of interest to vendors who wish to provide goods and services to the state as well as state agencies and municipalities. The Department of Commerce must re-certify your firm every year. Any changes before then which affect your firm's status as a minority business enterprise should be reported in writing with supporting documentation immediately to the Bureau of Minority Business Development at the Wisconsin Department of Commerce.
